Food Policy Consulting and Technical Assistance

I provide consulting and technical assistance on international policies and regulations to reduce purchases and consumption of energy-dense, ultra-processed foods to advocacy groups and governmental organizations, including ministries of health and finance. This includes analyzing draft regulations, providing evidence-based recommendations, disseminating research findings, providing scientific verification on mass media campaigns, submitting public comments, and organizing international scholars to provide letters of support or comments on proposed regulations. **In addition, I provide technical assistance to inform warning label design and test the impact of warnings vs. other labeling systems in countries where health organizations are considering passing labeling policies (whether through legislative action or health ministry regulatory authority).** Key policies for which I have performed these services include:
